

Paperwork for Newbies – A Road Map to Freedom

Start by going to <https://recorder.americaincorporated.org> and creating an account, including completing your profile info, uploading your photo and thumbprint and placing a publishing order. You will now have access to the Create Documents tab and can have all of these documents auto-populated and ready to print. Once your documents (either 1779 or 928s) are published, you will be able to order a Credentials Card!

Declaration of Naturalization (I'm an American!!!)

Required Documents: (recorded and published with a Missouri Assembly Recording Secretary)

- Declaration of the Naturalization Act of July 1779 (Print 2 copies of appropriate form.)
- Witness Testimony in the Form of an Affidavit (x2 - 2 people you've known for 7+ years)

This will put you back on the Land and soil as an American State National! However, until you record your 928 documents and send out your Notice Letters, you will not be eligible to serve as a State Citizen in the Missouri Assembly (Jural, Militia, etc.). Bookings can be set at missouriassembly.org under Correct Your Status, Step One, Book Now. Please scan and email color copies of your completed Witness Testimonies and your Birth Certificate to the Missouri Assembly Recording Secretary prior to your appointment. **Please note:** If your goal is to be 100% papered up (and 100% free from their system) you can skip the 1779 and just do the 928s and Notice Letters.

928 Documents (No More Fraud!)

Required Documents: (Recorded with your County Recorder of Deeds)

- Recording Cover Sheet
- Deed of Re-Conveyance
- Certificate of Assumed Name
- Act of Expatriation JOHN MARK DOE
- Act of Expatriation JOHN M. DOE
- Act of Expatriation JOHN DOE
- Foreign Sovereign Immunities Act
- Cancellation of All Prior Powers of Attorney
- DNA Paramount Claim
- Solemn Record and Proclamation of Lawful Marriage (if applicable)

Optional Documents: (You will need to add these to your Recording Cover Sheet)

- Witness Testimony in the Form of an Affidavit - x2 (recommended)
- Baby Deeds for sons & daughters under the age of 21 (recommended if applicable)
- Diagram of Fraud (recommended)
- Notice of Intent - Fee Schedule (recommended)
- Common Carry Declaration (if desired) (embossed Notary Seal)*

These documents need to be notarized by a de facto Notary Public and recorded in a de facto Recorder of Deeds office. The red thumbprint can be added after having the documents notarized and before recording them. Because of the cost of recording documents in their system, you may want to add any optional documents that you are considering with your original recording. Once you receive the recorded originals back, scan them in color (without removing the staple), place a publishing order and email them to an Assembly Recording Secretary for publishing on the LRS.

Notice Letters (Buh Bye!)

- Declaration of Political Status – S.O.S. (currently Antony Blinken) (embossed Notary Seal)*
- Revocation of Election to Pay Taxes (x2 – NY and DC)
- Voter Cancellation Registration (for all States that you have ever registered in)
- Military Letter – Permanent Discharge (if applicable)

These must be sent via Registered Mail w/Return Receipt, with the registered mail number written/typed on the letter. Scan a color copy of the letters, with the registered mail number on them, prior to mailing. Once mailed, scan a color copy of the stamped proof of mailing and then place a publishing order. Email the scanned letters and matching proof of mailing to an Assembly Recording Secretary for publishing on the LRS. You are now 100%!

* This can be done by a Notary Public or Missouri Assembly Recording Secretary.
